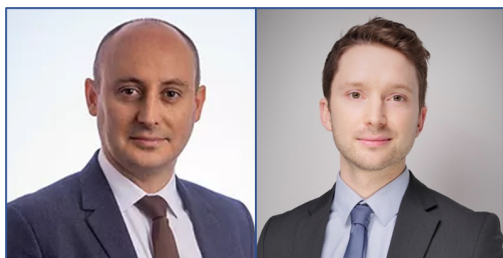


## **Current issues concerning the tax deductibility of financial expenses.**
